Energy Justice Project: Seeks to ensure California transitions equitably from dirty fossil fuels to 100% clean, renewable energy by mobilizing residents in low-income communities of color to advocate for the expansion of renewable energy access and small-scale clean energy generation in their communities. CEJAs Regenerate California campaign is part of this project, with our partner the Sierra Club. This campaign seeks to shut down all gas-fired power plants in California and replacing them with community-beneficial clean energy and other projects. CEJAs SOMAH (Solar on Multifamily Affordable Housing) program is another component that seeks to ensure equitable access to rooftop solar, energy bill savings and paid job training opportunities in th solar industry.

Green Zones uses place-based strategies to transform areas overburdened by pollution into healthy, thriving neighborhoods through comprehensive, community-led, solution-oriented, and collaborative approaches.
